INTRODUCTION

Since 1996, the Delaware Criminal Justice Council has worked with the Wilmington Police Department on analyzing the shooting incidents in the city. This report continues the effort of the Delaware Criminal Justice Council to collect and present data on the shooting victims and suspects in the City of Wilmington.¹ The 2009 report continues to review the nature of shootings in Wilmington by looking at various demographics of victims and known suspects including criminal history, age, race and sex. This report includes a multi-year shooting chart (Appendix A). It is anticipated that future reports on shootings in Wilmington will include additional multi-year comparison charts along with statistical analysis, trends, and projections.

Although this report focuses on the shootings that occurred in 2009, data will be presented from previous year's shooting reports when appropriate. The reader is referred to previous reports for more detail on shooting victims in Wilmington in previous years. All tables and data discussion is related to 2009 shootings unless otherwise noted.

METHODOLOGY

The data used for this report was obtained from the Wilmington Police Department and Delaware Criminal Justice Information System (DELJIS) criminal history searches on victims and suspects.

The analysis in this study, as with prior reports, is the result of taking information gathered from the crime reports for all of the 2009 complaints that reported a person being shot and placing them in a database. Incident information was obtained through Wilmington Police department and DELJIS searches. Criminal history was limited to State of Delaware records.

The nature of the data for this report requires some limitations on the analysis of and conclusions about the nature of shootings in Wilmington. In 2009 there were 107 shooting incidents. As of the date in which the information was obtained, 36 out of the 107 shooting incidents, or 33.6%, resulted in formal charges. The 107 shooting incidents resulted in 128 shooting victims. Out of the 107 shooting incidents, there were 126 suspects, of which 102 were identifiable by both sex and race and only 58 were further identifiable by age. Analysis of criminal history is grouped into the following categories: misdemeanor, felony, drug, and weapons arrests. Drug arrests include both felony and misdemeanor arrests for Title 16 offenses. Felony and misdemeanor arrests do not include drug arrests.

EXECUTIVE SUMMARY

In 2009, there were 107 shootings incidents in the City of Wilmington resulting in 128 shooting victims and 50 known suspects.²

For the 9 year period (1997-2005), the average number of annual shooting victims was 74.5. For the past four years (2006-2009), the average number of shooting victims has increased to 115.3. This signifies a 52.3% increase in the average number of shooting victims per year when compared to the earlier 9 year period.

Up until now, the years 2006 and 2007 had the highest two year total ever recorded in Wilmington with 193 shooting victims over a two year period. With 193 victims shot between 2008 and 2009, the number of shooting victims in a two-year period increased to 268 which is a 39% increase in the number of victims when compared to the number of victims shot between 2006 and 2007.

For the 9 year period (1995-2004) the average percentage of juvenile suspects was 10.5%. This percentage changed to 26.5% in 2005, 22.8% in 2006, 22.8% in 2007, and 20% in 2008. In 2009 there was a significant decrease in the percentage of juvenile suspects. Juveniles accounted for 13.8% of all shooting suspects in 2009. When all 14 years (1995-2009) are averaged for percent of juvenile shooting suspects, the average is 14.6%. The number indicates that the percent trend in the increasing percentage of juvenile suspects has begun to decrease. The 2009 percentage is more in line with the 15 year average when compared to the higher percentages of the prior four year period.

For the third time this report has looks at age of first contact with the criminal justice system for both suspects and victims. This information reveals that 76.6% of the 105 shooting victims with criminal histories in Delaware were juveniles at the time of their first arrest in Delaware.

Analysis of the 128 shooting victims revealed the following:

- Of the 128 shooting victims in 2009, 14 or 10.9% died as a result of their injuries.
- Males accounted for 92.2% of the shooting victims.
- Black males accounted for 83.6% of the shooting victims.
- The single largest category by age group of victims (24.2%) was between the ages of 18-21 years old.

Analysis of the 126 shooting suspects revealed the following

- In the 107 shooting incidents, there were 126 suspects that were reported.
- Of the incidents where at least one suspect was identified by race and sex, there were a total of 102 suspects.
 - 94.2% of those identified by race and sex were Black males.
- Of the 126 shooting suspects, only 58 suspects were further identified by race, sex, and age

2. Known suspects are defined as suspect that have been formally charge for the incident.


- Of the 58 suspects identified by race, sex, and age:
 - 13.8% were juveniles between 14 and 17 years old.
 - 43.1% were adults between 18 and 21 years old.
 - 22.4% were adults between 22 and 25 years old.
 - In total, 93.1% of the suspects were less than 30 years old.
- In 2009, for the seventh year in a row, there were no known shooting suspects less than 14 years old.

Analysis of the shooting incidents revealed the following:

- The month with the highest shootings occurred August of 2009 with 23 shootings.
- The day of the week with the most shooting victims was Friday.
- The hours of the day with the most victims occurred 8:00PM-9:00PM and 11:00PM-12:00AM.
- Of the 114 shooting victims who survived (14 out of 128 shooting victims died), 50% were cooperative in the shooting investigation.

Table Two is a summary of the case status for shooting incidents. Out of the 107 shooting incidents, 36 incidents resulted in arrests, 69 are pending cases, and 2 cases have been suspended. It should be noted that there is no data available for 2004 and 2005. The percentage of cases that were cleared by arrest of at least one suspect has remained relatively constant at approximately one-third of all shooting victims. We are not able to make valid multi-year comparisons for the Open, Pending, and Suspended categories as there was a change in definitions and counting practices between 2000 and 2001. Final clearance numbers are not available as these reported numbers represent a point in time and investigations are still on going at date of report production.

In 2009, there were 58 instances of an individual being identified by race, sex, and age as a shooting suspect. In almost one fourth (24.1%) of the 58 instances, the incident involved an 18-21 year old suspect shooting an 18-25 year old victim.
