Subject: Fourth Quarter 2005 New Castle County Detention Center Status Report

On December 31, 2005, with a population of 67, the Detention Center was 5 percent over capacity. The capacity of 64 beds was exceeded by 3 youth.

Admissions: During the fourth quarter of 2005, there were 285 admissions to the Detention Center.

Admission demographics: Of the 285 admissions, 55 were females and 230 were males. There were 203 African Americans, 7 Hispanics and 75 whites admitted to the Detention Center during the fourth quarter.

Leading charges at admission: The most frequent leading charges at admission for the fourth quarter were: *capias*, 33; possession with intent to deliver narcotics, 28; and, violation of probation, 22. 113 youth, or 40 percent, were admitted to the Detention Center for violent felonies.

Length of stay: On December 31, there were 67 youth at the Detention Center with an average length of stay (LOS) of 59 days and a maximum LOS of 271 days.

Of the 67 youth, there were 46 Family Court youth with an average LOS of 42 days, and 21 Superior Court youth with an average LOS of 96 days.

Snapshot demographics: Of the 67 youth on December 31, two were female and 65 were male. There were 51 African Americans, 13 whites and three Hispanic youths.

Youth's status: On December 31, 2005, there were 62 detained and 5 adjudicated youth.

Releases: 296 youth were released during the fourth quarter of 2005 with an average LOS of 27 days, and a maximum of 413 days.

Reading this table: This table shows that 62 percent of youth admitted to the New Castle County Detention Center during the fourth quarter of 2005 had prior admissions to secure detention, 28 percent to Level V, 31 percent to Level IV, and 44 percent to Level IIIR. Nineteen of the 107 youth without prior detention admissions had prior admissions to Levels IIIR, IV and/or V.
