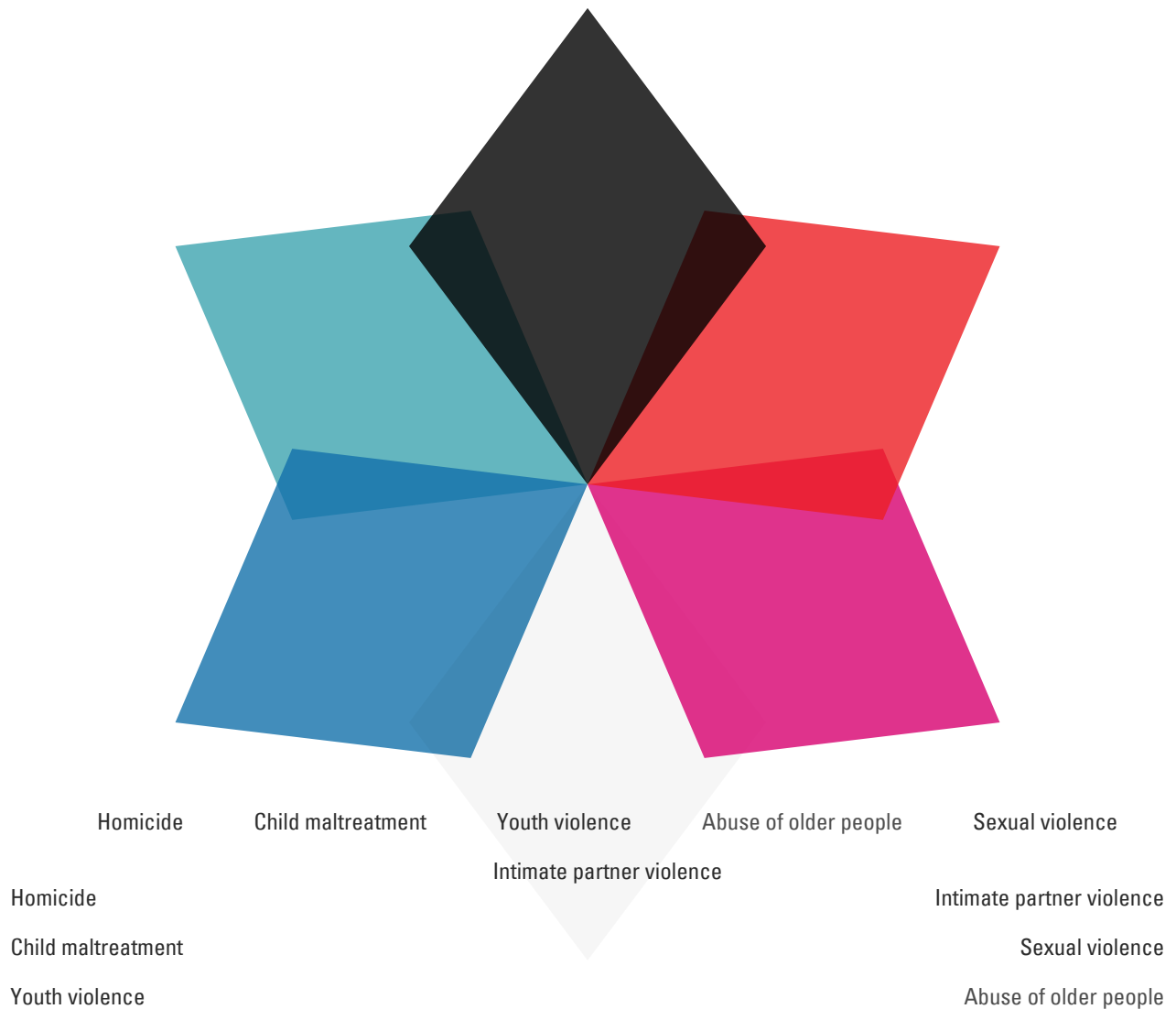
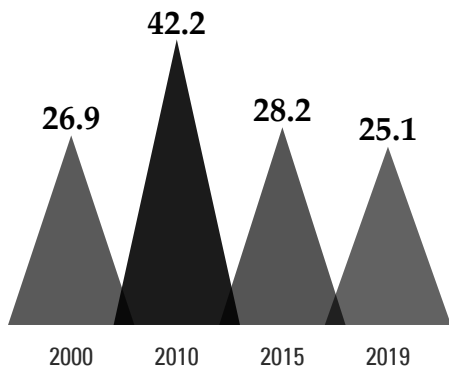

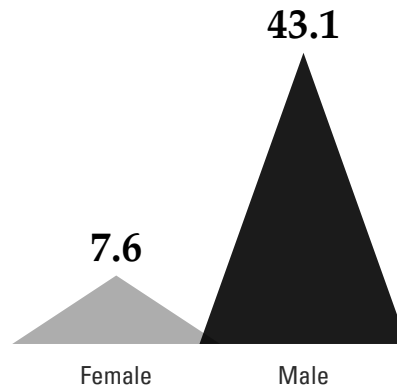

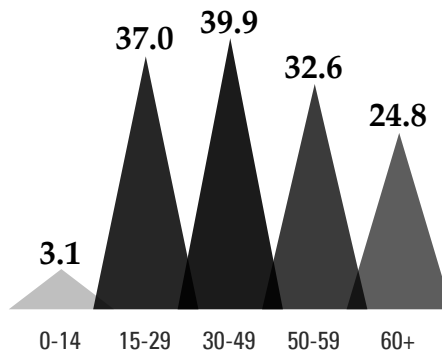
Homicide rate by year

Per 100 000 population, 2019



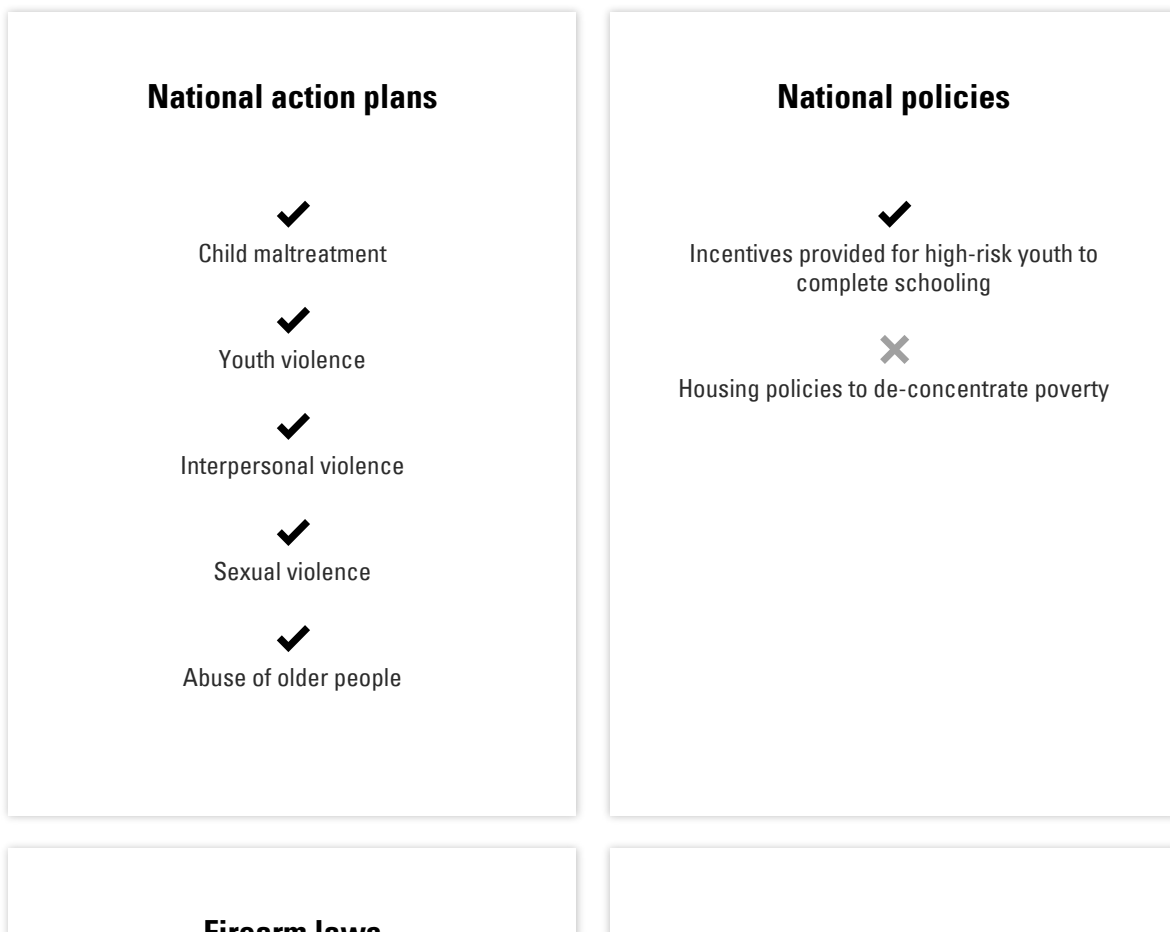
Homicide rate by age  
Per 100 000 population, 2019

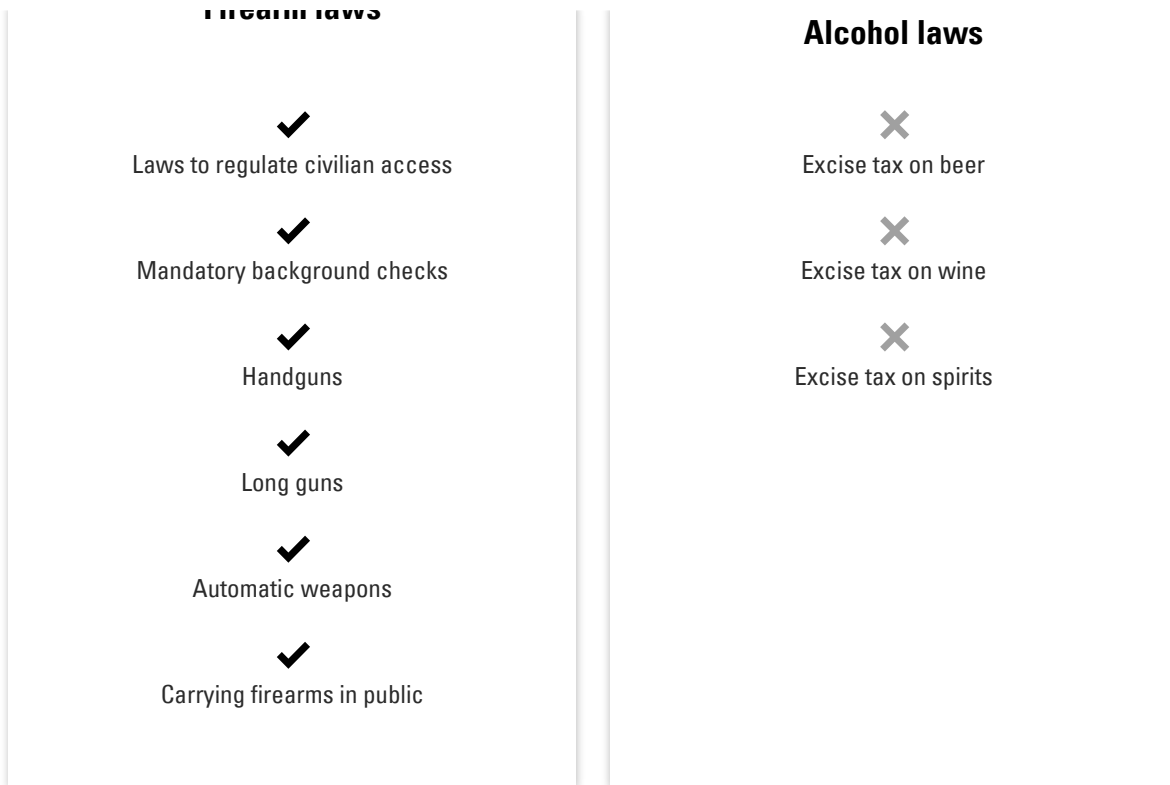

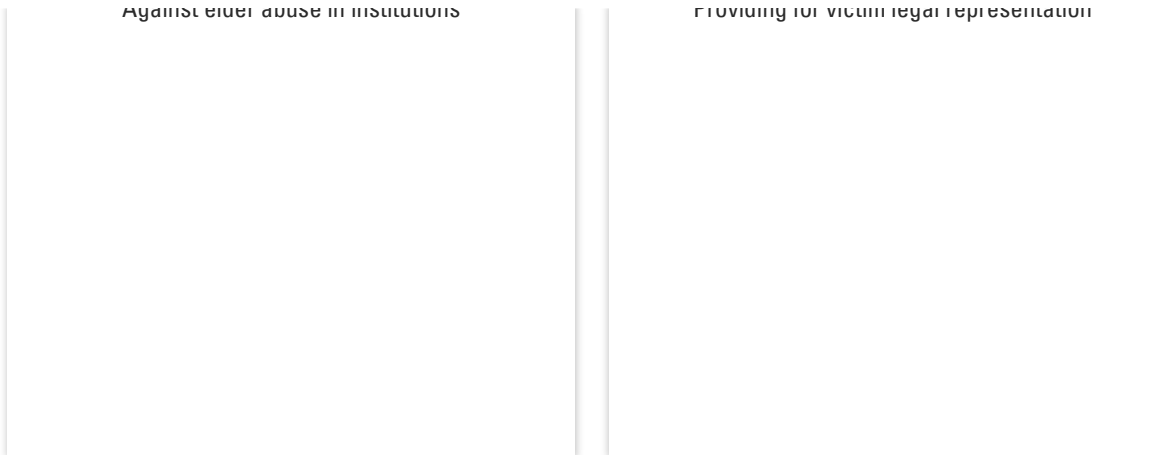

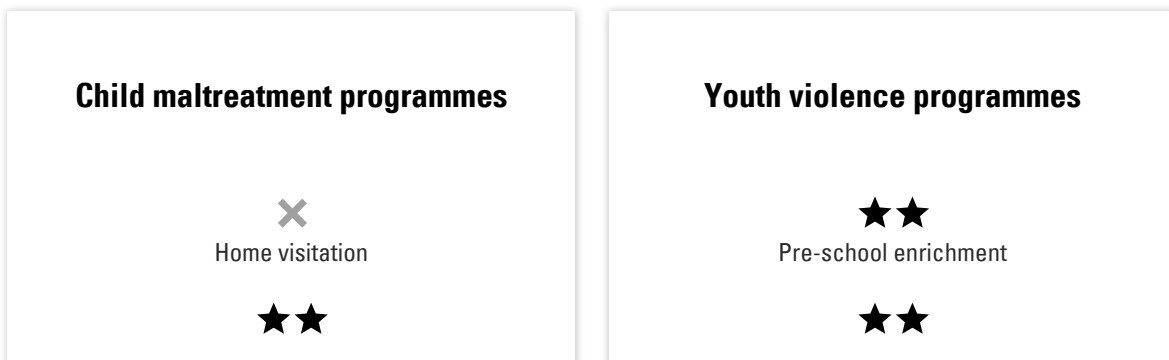
