I. Complete Description of the Facts:

On Friday, 12/22/23, at approximately 1948 hours, the officer responded to his residence in north Wilmington, DE., which is outside of the Delaware River and Bay Authority Police Department jurisdictional patrol area, in his assigned departmental vehicle (814), while on duty, without authorization from his on-duty supervisor, when the CAD system showed him out on a security check at ILG (New Castle Airport) at approximately 1949 hours, which he reported to the departmental dispatcher, and the Patrol Explorer GPS Report reflected that he was never on site.

On Saturday, 12/23/23, at approximately 2025 hours, the officer responded to his residence in north Wilmington, DE., which is outside of the Delaware River and Bay Authority Police Department jurisdictional patrol area, in his assigned departmental vehicle (814), while on duty, without authorization from his on-duty supervisor, and then responded from that location to a disabled vehicle on the Delaware Memorial Bridge at a very high rate of speed (between approximately 93 to 109 mph) arriving at approximately 2055 hours, approximately 15 minutes after being dispatched.
